4. ATTENDANCE AT MEETINGS - Note for councillors

• Clerk Posted "Following a visit to the Site the Hope Mansell Parish Council has concerns as to whether the proposed building is appropriate given its size and design. Design and Appearance Given its considerable size and its design, the proposed building would not fit harmoniously into the surrounding landscape, located as it would be at the highest point on the site and very close to the only access track. Because of this the proposals would change substantially the appearance of the area and block public views from the track down the valley. In addition, it appears that the proposed new footprint would be some 3 times the size of the existing. Given that the proposals are described as an extension this would seem to be excessive. Overlooking and Loss of Privacy Much of the house and curtilage of Lily Cottage, located some 60 metres south, and much lower than the proposed building, would be clearly visible from the elevated position, and this would undoubtedly constitute a highly undesirable overlook and loss of privacy. Should the Council be minded to grant planning permission a condition should be imposed to create some form of attractive screen to mitigate this. General Access The Proposed dwelling is served by a Single Track, that currently serves 7 properties The council has concerns about the access into the proposed development"

• Environmental agency – Re Flooding at "the goldmine"

This incident was caused by a buildup of water in the Lea Bailey Level escaping suddenly the cause is fully understood by the mine owner and the Forestry Commission who have some overseeing role have also been involved.

When this happened 4 small 'trucks' sitting on the railway line in the level and the rails themselves were engulfed with water. There was some oil on the tracks and underneath the trucks which we believe was the cause of the oil observed downstream. As far as we know there was no leakage from any equipment or stored oil. If residents who were affected details are forwarded the agency will liaise directly with them"
