4. Open Forum – To hear views of local residents on parish matters

Terry Finch reported that the roads are awful -summer house pitch / Upper house towards Harechurch / Hopesash farm where the road is breaking up . To Raise with Locality steward,

- 5. Meeting with PC Barrowdale-Smith on local issues Speeding / Barbed wire / dogs PC Barrowdale Smith advised he is part of the safer neighbourhood initiative.
  - **5.1** Speeding at BLE S Heath asked PC Barrowdale-Smith for help. PC Barrowdale-Smith advised to contact Ian Connelly. He advised we can loan a SIDS Machine. Clerk advised this can cost £540. PC Barrowdale Smith offered to come along to do speed enforcement at BLE C Elmitt advised that the parish feels a bit forgotten about. PC Barrowdale-Smith advised residents to call in & log the issue. S Heath to contact direct.
  - 5.2 CEImitt raised the issue of the Viewpoint. Problems with Anti- social behaviour .PC Barrowdale Smith advised that the Barbed wire is legal. He also advised that he visits the viewpoint to discover that people are sitting in their cars. PC Barrowdale-Smith advised that a TRO could be raised to put a sign up that it's open only between dawn and dusk. Clerk to contact Balfour Beatty.
  - 5.3 CEImitt asked regarding constant dog nuisance at Palmers Oak Dancing Green, where dogs bark all day and night unless they are taken indoors. 10 Dogs .No response received from environmental health. PC Barrowdale Smith suggested that we email him direct and he will remind environmental health about the issue. Clerk to email .

6. To meet with Balfour Beatty Locality steward – Kevin Williams - To receive update on the Roads

  - 7.1 To note Changes to the lengthsman scheme
    Changes noted that PC contribute £60/km for roads with Herefordshire Council contributing
    £30/km, and after 2017/18 there will be no contribution at all from Herefordshire.
  - 7.2 To approve membership of the scheme for 2017/18

It was thought that the raising of the precept was not worth it, and that the village can get by without a lengthsman. Clerk not to register interest in the lengthsman Scheme for next year. People to look after their own village rather than pay an increased precept. All Agreed.

Owners of Harechurch Barn stated that they wanted a small dwelling for disabled visitor's holiday let. It's a resubmission of last year's plans. G Phelps stated that the Parish Council had no power in this matter. Parish Councils only comment was regarding access. There are only 2 properties with disabled access. No further comment to make.
